Terms of Use

Effective Date. June 5th, 2020

Definitions. "Photer" means Al Pictures, Inc. a Delaware corporation with its address at 111 Pier Avenue, Suite 100, Hermosa Beach, CA 90274. "PHOTER Content" means content owned or licensed by PHOTER. "Photer Parties" means Photer together with its employees, managers, officers or agents. "Service" means the Photer service, or any applications (including mobile applications) made available by Photer. "Terms of Use" means these terms of use, as they may be amended from time to time by Photer in its discretion pursuant to the terms hereof. "You" means you, the user of the Service.
